Dear Laura Bradley,

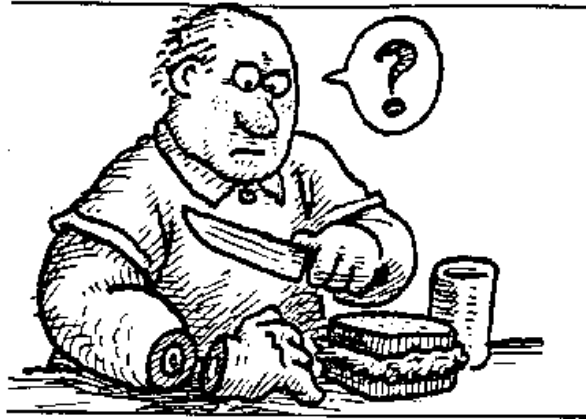
No Jury without a living Plaintiff

Injunction

The men and women of Thames Valley Police, any tipstaff, any corporate Bailiffs, for example, those of Marstons, Serco et al, and any such “force” are not permitted on the property and house of the one we know as Michael Burke and are not to come within a 100 yards of wherever he may be.

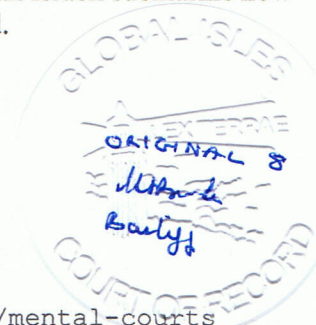
